Pine Grove Cremation Lots: Cost of Lot = \$125 Perpetual Care per Lot = \$300

Pine Grove Double Full Burial Lots: Cost of Lot = \$200 Perpetual Care per Lot = \$500

Corner Markers:

Cremation Lots – Lot corner markers are preinstalled by the Town and additional corner markers are not allowed.

Full Burial Lots – Corner markers are required for full burial lots. Markers may be provided by the lot holder (with installation by the Sexton) or may be ordered by the Town on behalf of the lot holder. The actual cost of the corner markers and delivery charges will be billed to the lot holder in addition to any other fees. Markers must be granite and installed flush to the surrounding ground surface.

Corner Marker Installation: Corner markers for full burial lots may only be installed by the Sexton and Cemetery Department workers. Corner marker installation fee (per lot) is \$45 payable to the Town of Fitzwilliam along with corner marker costs (if applicable).

Payment: Payment in full is required prior to preparation and issuing of a Certificate of Right to Inter. Checks are to be made payable to Town of Fitzwilliam NH.

Lot holders shall notify the Trustees in writing whenever their contact information changes. In addition, if the ownership of the Right to Inter changes for any reason such as the death of the holder, the Trustees must be notified of the transfer of ownership through the estate settlement process with related documentation submitted to the Trustees.

Resale of any Cemetery Lot Right to Inter shall only be to the Town of Fitzwilliam.

Abandoned lots may be declared forfeited in accordance with NH RSA 289:18.
