#### 2020 Car Raffle Disclaimer

- I. You must be 18 years of age or older to purchase a raffle ticket and participate in this raffle.
- II. The purchase price for one raffle ticket \$50.00. If an entrant's check or credit card is dishonored by the bank or credit card company, the entry ticket will be invalid unless full payment is received prior to the raffle drawing.
- III. No more than 250 tickets will be sold. Any monies turned in after the raffle closes will be returned to the entrant. All tickets will be recorded in the order received. Original raffle ticket is required to redeem the prize.
- IV. If 250 raffle tickets are sold before the raffle closes, each ticket will have a 1-in-250 chance in winning, and the prizes will be as follows.
