To see if the town will vote to raise and appropriate the sum of Two Million Nine Hundred Seven Thousand Four Hundred Fifty Dollars \$(2,907,450) for the purpose of furnishing, constructing, and installing facilities and equipment to provide a 1 gigabit, Fiber to the premises, Fiber Optic Broadband Network throughout the Town of Fitzwilliam; with One Million Six Hundred Twenty Two thousand Five Hundred Dollars (\$1,622,500) of such sum to be raised through the issuance of bonds or notes under and in compliance with the Municipal Finance Act (RSA 33:1 et seq. as amended) and One Million Two Hundred Eighty Four thousand Nine Hundred Fifty Dollars (\$1,284,950) of such sum as a donation from the broadband provider, Consolidated Communications, Inc.; to authorize the Selectman to apply for, obtain and accept federal, state or other aid, gifts and donations, if any, which may be available for said project and to comply with all laws applicable to said project; to authorize the Selectman to issue, negotiate, sell and deliver such bonds or notes and to determine the rate of interest thereon; Recommended by the Board of Selectman, Recommended by the Budget Committee (3/5 ballot vote required).

**Article 19 Road Reclassification**

To see if the town will vote to discontinue subject to gates and bars, pursuant to RSA 231:45, any and all portions of Gap Mountain Road (a.k.a. Upper Gap Mountain Road) which may have been affected by the reclassification vote taken under Article 22 of the 2016 Fitzwilliam Annual Town Meeting, and which lies south of a point 750 feet southerly of the Fitzwilliam-Troy town line, as measured along said road; with the result that the portion of said road running from said town line southerly to the driveway leading from said road to the residence of Dana C. and Cheryl A. Pinney shall remain a Class V highway in accord with said 2019 vote; whereas the portion of said road lying south of said Pinney driveway, and extending beyond the intersection with Cobleigh Hill Road, shall again be a Class VI highway

(By Petition) To see if the town will vote to ban the sale and use of Binary Explosives such as, but not limited to, Tannerite, or take any action thereon. Furthermore, we would ask for a ballot vote to ensure those voting are registered Fitzwilliam voters.





**Article 21    Petition**

(By Petition) We, the undersigned, as registered voters in the Town of Fitzwilliam, NH, in Cheshire County, want to enter a warrant petition to the Town of Fitzwilliam voters for an issue in our wonderful quiet community; excessive speeds and noise from motor vehicles. Some motorists are flagrantly disregarding NH motor vehicle laws, for both speed and noise. Speeders are driving up to 50 mph on Route 119 East and West and on Route 12 North and South near the Town Center, as well as on other roads entering the Town Common (Upper & Lower Troy Rd, and Templeton Tnpk, for examples). This is in violation of RSA 265:60 which regulates safe motor vehicle speeds. Some also have illegal exhausts with no mufflers or malfunctioning mufflers, violating RSA 266:59 which regulates motor vehicle noise. Residents of Fitzwilliam are entitled to quiet enjoyment of their dwellings, and to be safe on public roads. We respectfully ask the Town of Fitzwilliam to enforce the existing speed limit and noise laws, as per the attached Addendum: Pertinent Motor Vehicle Laws.
